**Please read the following agreement and sign below:**

This Release and Waiver of Liability (the "Release") executed on this day in favor of You Got Flowers, a non-profit corporation, their directors, officers, employees, agents and affiliates (collectively, "YGF").

The Volunteer desires to work as a volunteer for YGF and engage in the activities related to being a volunteer at YGF ("Activities"), which may include pickup, processing and delivery of flowers and floral arrangements in the area served by YGF. The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

**Release and Waiver:** Volunteer does hereby waive, release and forever discharge and hold harmless YGF and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with YGF. Volunteer understands that this Release discharges YGF from any liability or claim that the Volunteer may have against YGF with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's Activities with YGF, whether caused by the negligence of YGF or its officers, directors, employees, or agents or otherwise. Volunteer also understands that YGF does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance or medical expense reimbursement in the event of injury or illness.

**Medical Treatment:** Volunteer does hereby release and forever discharge YGF from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered by YGF or any other provider in connection with the Volunteer's Activities with YGF.

**Assumption of the Risk:** Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases YGF from all liability for injury, illness, death, or property damage resulting from the Activities.

**Insurance:** The Volunteer understands that YGF does not carry or maintain health, medical, or disability insurance. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

**Photographic Release:** Volunteer does hereby grant and convey unto YGF all rights, title, and interest in any and all photographic images and video or audio recordings made by YGF during the Volunteer's Activities with YGF, including, but not limited to, the right to use such images or recordings for the promotion of YGF and any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other:** Volunteers shall not engage in political or religious activities while performing the Activities on behalf of YGF. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by Commonwealth of Massachusetts and that this Release shall be governed by and interpreted in accordance with the laws of the Commonwealth of Massachusetts. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
